

## **ALLEN HILL, CHIEF INFORMATION OFFICER - BIOGRAPHY**

Allen Hill is the Chief Information Officer (CIO) leading the Office of the Chief Information Officer (OCIO), within the Office of the Managing Director (OMD) for the Federal Communications Commission (FCC). The Chief Information Officer oversees an approximately \$89M IT portfolio providing technology support to 19 Bureaus and Offices that utilize over 200 systems across the Commission—including providing Information Technology (IT) support to FCC Auctions, which have produced over \$23B in revenue this year. As CIO, he oversees IT enterprise planning and performance, operations, cybersecurity, budget and acquisition, engineering and architecture, applications development and support, data and policy, and stakeholder relations for the agency. Allen's expertise and knowledge of all aspects of IT development, deployment, and information security, combined with his demonstrated ability to provide executive leadership over complex IT portfolios, supports the FCC's ability to execute the modernization of IT operations enterprise-wide.



Prior to being named Chief Information Officer, Allen worked at the U.S. General Services Administration's Federal Acquisition Service as the Deputy Assistant Commissioner for Category Management, Office of Information Technology Category providing executive leadership over a portfolio of acquisition solutions through which customer agencies procure more than \$32 billion in IT products and services. These solutions include the Government-wide Acquisition Contracts (GWACs) Alliant 2, Alliant Small Business 2, Polaris, VETS2 and 8(a) STARS. In addition, his portfolio also includes Enterprise Infrastructure Solutions (EIS) and the USAccess shared services program.

Allen previously served as the Director of Telecommunication Services for GSA, where he was responsible for a portfolio of contracts that provide government agencies with a diverse set of telecommunications services valued at over \$3 billion annually. Allen came to the GSA from the Department of Education where he served as the Director, Office of the Chief Information Officer (OCIO). During his five years with ED's OCIO, Allen led the strategic planning, policy development, and executive management of all Information Technology (IT), Management (IM) and Assurance (IA) systems. He oversaw \$50M+ in IT support services contracts, including those related to network, mobile, and security. His work has helped ensure that millions of students and thousands of schools throughout the nation receive their funds.

Previously, Allen served as the Director of Pacific Operations at CACI and Senior Technical Advisor with Verizon Business working with the Defense Information System Agency (DISA). He also has 20 years of experience with the US Air Force.

Allen's certifications include Senior-Level Federal Acquisition Certification (FAC) for Program and Project Managers (PPM), Management Professional from the Project Management Institute, and Certified Information Systems Security Professional.

Allen received his Bachelor of Science from the University of Maryland and a Masters of Science in Information Technology Project Management and Leadership from Capella University.
